

CIRCULAR

It is notified for general information that HRMS and Payroll module of the ICAR- MIS / FMS is being implemented at IVRI Izatnagar and its campuses & regional stations. The salary for the month of the May, 2016 will be processed using MIS/FMS System. In the new payroll system, income tax will be calculated and deducted on monthly basis. All the scientific/Technical/Administrative and Supporting Staff are requested to provide the saving details (as per annexure - I), if they want to claim income tax exemption (HBA Accrued Interest / Medical Insurance etc.) which are other than salary saving to the ARIS Cell before 20th May, 2016 otherwise Income Tax will be calculated automatically from salary based on income as well as saving details already fed in the FMS like GPF/NPS/Salary Saving Policy/GSLIS etc.)
