

**Sub: Representations of the Technical personnel of this Institute- reg:-**

Sir,

This has reference to your letter No. 35-14/86-E.I dated 19.5.2015 on the subject cited above. I am to inform you that a proposal for demerging the technical post in T-7-8 grade into a separate T-7 and T-8 grades and for granting the PB-4 (₹ 37,400 - ₹ 67000 + GP - ₹ 8700) to the T-9 post was sent to the Ministry of Finance. Ministry of Finance did not support the creation of the higher grade than the maximum grade available under the merit promotion scheme of the Technical Service Rules because the level cut out during V Central Pay Commission was below the highest grade.

The Ministry of Finance has further opined that above proposal could be re-examined after 7<sup>th</sup> Pay Commission's recommendations are adopted by the ICAR.

Further, as decided by the Competent Authority the proposal to grant higher pay scales and grant of financial up-gradation for T-9 grade to PB-IV + GP Rs. 8700/- has been sent to VII Central Pay Commission for consideration.

All the twenty three representationists of the Institute may be informed accordingly.
