- i) I am citizen of India.
- ii) I shall not approach any foreign agency for financial assistance without prior permission of ICAR.
- iii) I shall not enter into any kind of correspondence with any foreign agency except through ICAR.
- iv) The certificate so granted shall not involve any commitment on the part of ICAR/Govt. of India to release foreign exchange etc. to me in addition to what I am normally/usually entitled.
- v) I shall not take part in any activity abroad prejudicial to the sovereignty and integrity of India, which would contravene the provisions of the CCS Conduct Rules, 1864 as amended from time to time, as made applicable to the employees of the ICAR.
- vi) My departure from India shall not be detrimental to the security of India. I shall return to duty in ICAR, if the leave is sanctioned and I shall not ask for any extension of leave.
- vii) My presence outside India shall not prejudice the friendly relations of India with any foreign country.
- viii) I have any time during the period of five years immediately preceding the date of my application, not been convicted by a Court in India for offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years.
- ix) No proceeding in respect of any offence alleged to have been committed by me pending before a criminal court in India.
- x) No warrants or summons for the appearance of warrant for the arrest in respect of me, has been issued by a court under any law for the time being in force or that in order prohibiting the departure from India in respect of me, has been made by any such court.
- xi) I have not been repatriated and have not been reimbursed the expenditure incurred in connection with such repatriation.
