2. The Anti-Ragging Squad shall ensure the compliance of the provisions as contained in UGC Regulation, 2009.

3. The Anti-Ragging Squad will maintain vigil, oversight and patrolling functions and shall remain mobile, alert and active at all times.

4. The Anti-Ragging Squad shall make surprise raids on Hostels and other places vulnerable to incidence of and having the potential of, ragging and shall be empowered to inspect such places.

5. The Anti-Ragging Squad will conduct and on-the-spot enquiry into any incident of Ragging referred to it by the Head of the Institutions or any member of the faculty or any member of the staff or any student or any parent or guardian or any employee of a service provider or by any other person, as the case may be; and the enquiry report alongwith recommendations shall be submitted to the Anti-Ragging Committee for action under clause (a) of Regulation 9.1.

6. The Anti-Ragging Squad will conduct such enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other witnesses to place before it the facts, documents and views concerning the incident of ragging, and considering such other relevant information as may be required.
