NOTE:

1. *Hostel fee will be deposited on the arrival of students in the campus.
2. The semester will be concluded by 13.10.2021 (total 94 days). All holidays including Sunday and extra class as and when required to be counted as working days to add in the academic calendar.
3. In case holiday falls on any above date, the schedule will be shifted to next working day.

b) **For offering Practical Courses in the 2nd Semester 2020-21:**

Further, during 1st Semester academic session 2020-21 only theory courses were offered, to the students considering the COVID-19 pandemic situation in the country and the classes were held online. We were hopeful for the COVID situation to become normal while the student registers for 2nd Semester. However, as per the State Government/ recent UGC guidelines, the teaching will remain online until the situation become normal. During the 2nd Semester most of the courses are practical in nature. Under such circumstances it has been decided to conduct practical classes online by using online platform through demonstration and video clips and other suitable methods by the faculty members till the students resume study offline. Once the students report back in the campus, the practical may be conducted offline as usual.

The above-mentioned decisions are recommended and approved, as special measures requires to be taken for the health & safety of faculty, students and officials of IVRI Deemed University subject to rectification in the ensuing meeting of the Academic Council.
