MVSc & PhD Students

Step-I - Online presentation before the Outside Examiner, SAC & HD/BOS Chairperson:

It is decided that the students have to present a 15 minutes presentation comprising of 10-15 slide before the Outside Examiner, SAC, HD/BOS Chairperson.

Step-II -Online submission of final Viva-Voce Report:

After recommendations of the Examiner in the final Viva-Voce Examination, the concerned Guide should submit the final viva-voce report in the prescribed format duly signed digitally by the Outside Examiner, SAC and countersigned by HD/BOS Chairperson with the confirmation that all the suggestion given by the outside examiner have been incorporated in the final thesis through email to the Controller of Examiner / Academic Section (email id universityivri@gmail.com / acadsec17@gmail.com).

Step-III Submission of Soft copy of thesis in PDF format & online PDC clearance format, no dues certificates and undertaking in the prescribed format to the Deemed University for issue of PDC/Transcript:

Students will submit the soft copy of the thesis duly signed digitally along with other related documents available on Institute's Website and also annexed at Annexure-I online to the Academic Section for issuing them Provisional Degree Certificate/ Transcript.

Due to any administrative reason, student is not able to get any of the requisite no dues, he/she has to submit an undertaking in the prescribed format alongwith the reason, duly signed by him/her & Countersigned by the Advisor and HD/ BOS Chairperson to the effect that he/she has to submit remaining no dues with the copies of hard bound thesis within one month after the Deemed University re-opens.

The student will not be paid the remaining / last month's scholarship / fellowship without production of a certificate from the Head of Division that a copy of the hard bound thesis and final no dues certificate from all concerned have been submitted to the Academic Section.

BVSc & AH Students

The following guidelines have to be followed by the BVSc & AH Students for issue of PDC & Transcript:

After successful completion of degree programme, the students have to submit the online PDC clearance format, no dues certificates and undertaking in the prescribed format available on Institute's Website and also annexed at Annexure-II.

Due to any administrative reason, student is not able to get any of the requisite no dues, he/she has to submit an undertaking in the prescribed format alongwith the reason, duly signed by him/her & Countersigned by the Advisor and Coordinator (UG) to the effect that he/she has to submit remaining no dues within one month after the Deemed University re-opens.

The student will not be paid the remaining / last month's internship allowance without production of a certificate from the Advisor / Coordinator (UG) that the final no dues certificate have been submitted to the Academic Section.
