OFFICE ORDER

Job contract for LPM work (a. Milking and allied work b. Cleaning and maintenance of animal sheds c. Chaff and allied work. d. Maintenance of sheep & goat and its shed farm) was awarded to M/S Elite Associate, Agra vide letter no.5-1/2011-12/Contract dt.28.2.2013 for one year. The contract was terminated on 31.1.2014 before completion of one year.


From time to time, the firm was requested to improve its functioning and also to submit the document related to deposit of EPF of the workers deployed by them. But instead of improving the functioning and submitting the required documents, allegation were made against the officials of IVRI.

To investigate/examining the facts a committee was constituted by the competent authority. The committee in its report stated that there have been several complaints about non compliance of work order and also the firm has not completed with the condition of the agreement by giving the proof of deposit of EPF and thus violated the clause of agreement deed. Moreover, the institute was forced to cancel the contract before its completion period.

The firm had intimated, that they have submitted writ petition No.30099-2016 in Honourable High Court for EPF. The Honourable High Court has instructed to EPF commissioner, Agra to examine the document of EPF and submit no dues certificate within four months vide letter dated 29.7.2016. The Assistant EPF Commissioner, Agra when contacted in this regard, intimated that an enquiry under Section 7A of the employee provident fund and Miscellaneous Provision Act 1952 for determination of dues in respect of employee engaged by M/S Elite Associate, Agra is in process.

In view of the above facts, the firm M/S Elite Associate, Agra is debarred to participate in the Institute's any future tenders with immediate effect, till the decision of EPF Commissioner, Agra is received in this regard.
