Circular

As the counting of the ballot of the IJSC Election - 2019 is to be held on 03.01.2019 from 5.30 PM onwards, the following instructions is issued to the Counting Officer for smooth counting :-

The Counting Officer will reject a ballot paper on the following grounds :-

- i) If ballot paper bears no mark at all ; or
- ii) If it bears marks in blank area, that is to say, at the back or entire in the blank area; or
- iii) If it bears marks made otherwise than with the instrument (cross mark rubber stamp) supplied for the purpose; or
- iv) If votes are given in favour of more than found candidates ; or
- v) If it is so damages or mutilated that its identity as a genuine ballot paper cannot be established ; or
- vi) If it bears a serial number different from the serial number of the ballot papers authorized for use at the particular polling station; or
- vii) If it does not bear both the signature of the Returning Officer and Election Officer.

Other Instructions :


- viii) A ballot paper will be kept in a separate envelope when there is a dispute between the counting agents of the candidates as to whether the ballot paper is valid or as to the candidate to whom vote is given.
- x) Every one will be required to fully cooperate with the Officers in maintaining strict discipline and order inside the counting hall. They should carry out all directions given by the Counting Officer. They should note that the Counting Officer may send out the counting hall any person who persists in disobeying his directions.

- xi) No counting agents and others will be allowed to go outside counting hall during counting process. In other words, when once counting agents and others are inside the counting hall, they will ordinarily be allowed to go outside only after the declaration of result.
- xii) On production of his letter of appointment and the identity card before the Counting Officer, the counting agent will be required to sign before the Counting Officer the declaration contained in his letter of appointment regarding maintenance of secrecy of voting. After verification of the letter of appointment, identity card and declaration, the Counting Officer will permit the counting agent to enter the counting hall.
- xiii) Side by side, the work of tabulating the result of counting will be done by the Counting Officer and make bundles of ballot papers.

All the Counting Officers are requested to follow the above instructions and comply the same while counting the ballot for IJSC election-2019.
