CIRCULAR

This has reference to Ministry of Home Affairs, Govt. of India of Order no. 40-3-2020-DM-I(A) dated 15.04.2020 that lockdown will continue to remain in force upto 3rd May, 2020 to contain the spread of COVID-19 in the country.

As per guidelines dated 15.04.2020 of Ministry of Home Affairs, offices of the Govt. of India, its Autonomous/Subordinate offices and public corporation shall remain closed. Hence, being an Autonomous Body of Govt. of India, this Institute including Deemed University will also remain closed for the aforesaid period.

However, the essential service like dairy operation, feed & fodder supply/sanitation services, security services, including disinfestations, water & electric supply, Human Hospital /Referral Vety. Polyclinic/Horticulture Services/Wildlife Services/livestock/experimental Animal maintenance etc. shall continue uninterruptedly with minimum possible skeletal manpower. The Pay & Accounts offices and other offices dealing with payments shall remain open with bare minimum staff. The duties in these essential services will be fixed by the Head of Divisions/Incharges without jeopardizing the health of staff members. All other staff will work from home & keep ready themselves to attend the office on urgency whenever required.

The Deemed University shall also remain closed, however, it is expected to maintain the academic schedule through online teaching.

All the officers/staff are hereby instructed to maintain the social distancing and to wear face-cover which is compulsory in all public places & also while working in their sections/Divisions.
