OFFICE ORDER

On the recommendations of the Departmental Promotion Committee, the Director, IVRI is pleased to promote the following skilled support staff to the posts of **Lower Division clerk** in the level-2 of pay matrix as per 7th CPC (Rs 5200-20200 plus GP 1900, pre-revised) on seniority-cum-fitness basis with effect from the date they join their duties as LDC at their present place of posting and final place of posting will be decided later on:-

The above official will be required to qualify a typing test with a minimum speed of 35 words per minute in English or 30 words per minute in Hindi within a period of one year from the date of their appointment as LDC failing which no annual increment shall be allowed until he/she passes the typing test. However, as the above officials are above 45 years of age, this condition has been waived off by the Competent Authority.

On promotion, they will be on probation for a period of two years from the date of their joining. Failure to complete the probationary period satisfactory will liable them to be reverted back to the post of skilled Support Staff. Other terms and conditions of the service shall be governed by the rules/instructions issued by the Govt. Of India /ICAR from time to time.

They are also required to exercise an option within a period of one month from the date of issue of this office order, if they desire to get their pay fixed under FR-22 (I) in accordance with O.M.No.1/10/89 Estt. (Pay -I) dated 30.08.89 (GOI, DOPT) whether their pay is to be fixed on new post straight away or the date of increment in the old post. If no option is received from them within the stipulated period their pay will be fixed as per rules. Further, if they have already been granted next higher Grade Pay under the MACP Scheme, they are not entitled for any fixation.

The inter-se-seniority of the above officials in the grade of LDC will be fixed as per Govt.of India /ICAR rules , which will be subject to change, if in due course any other person(s) whose representation/vigilance/disciplinary proceedings etc. under consideration, is promoted as LDC.

In case the promotion is acceptable to the above officials, they may submit their acceptance /joining report to **this office** with a copy to the **concerned establishment** section within **30 days** from the date of issue of this office order.
