Sir/Madam,

In connection with above, I am directed to say that ASRB is going to take up the assessment cases under the Revised Career Advancement Scheme (CAS) for consideration of promotion from Sr. Scientist grade (RGP ₹ 9000) to Principal Scientist grade (RGP ₹ 10,000) in respect of such Sr. Scientists (RGP ₹ 9000/-) who have rendered 3 years of qualifying service in the grade of Sr. Scientist (RGP ₹ 9000) upto 31-03-2019. Three copies of Assessment Proformae of such Sr. Scientists (duly filled in by the Sr. Scientist himself/herself and authenticated/verified by the Director of the Institute) may be forwarded to the Board latest by 16-09-2019.

2. The proposals in respect of Sr. Scientists, who were considered earlier under the revised CAS for the relevant assessment period, but not recommended for promotion to the grade of Principal Scientist from the due date, will be considered for next evaluation as per the revised CAS after 2 years from the due date of promotion.

(Illustration:- Suppose, under the revised CAS, a Senior Scientist was considered to the grade of Principal Scientist for the period from 01-01-2014 to 31-12-2016 with the due date of promotion being 01-01-2017 but not recommended for promotion, the assessment proformae required to be submitted for next evaluation would relate to the period from 01-01-2016 to 31-12-2018 and his /her revised due date of promotion shall be 01-01-2019). Three copies of assessment proformae of such Sr. Scientists for the revised assessment period may also be forwarded to ASRB by 16-09-2019.

3. The Directors of the Institutes, while forwarding the assessment proformae of the Sr. Scientists with Certificate mentioned at para 1 above, may also certify the authenticity of the attributes on each page of the assessment proformae (S.No. 1 - S.No.11-B) indicating the genuineness of the attributes in terms of actual contributions made by the concerned scientist without any duplicacy of records. Further, against Col. no. 9 of the assessment proforma of the candidate, it may be certified/endorsed whether the candidate was placed in RGP ₹ 9000 through CAS Assessment Committee or lateral entry through ASRB.

4. Only the proformae uploaded/available on the ASRB website (www.asrb.org.in) may please be used for proposal. Incomplete proposal and the proposals not in the prescribed format will be rejected and will not be considered during this spell of programs for CAS.

5. As far as possible, the candidates/Sr. Scientists may furnish the information in the given space in the relevant assessment proforma only, rather than resorting to annexures. It may also be ensured that the assessment proposals are received in ASRB on or before 16-09-2019. The proposal received after the closing date will not be considered during this spell of programs.
