Sir,

As you are aware, the Council is running the Scheme for **Emeritus Professor** in the field of **Agriculture and Allied Sciences**, to be located at State Agricultural Universities/ICAR-DUs/CAUs/ CUs with agriculture faculty under National Agricultural Research & Education System (NARES) as per Guidelines of the Scheme (**Please visit www.icar.org.in for details and revised Guidelines of Emeritus Professor Scheme**). Applications are hereby invited from eligible superannuated/superannuating professionals of NARES in the field of agriculture and allied sciences for filling up of Emeritus Professor positions.

The ICAR-Emeritus Professor programme aims to utilize the talent and services of outstanding superannuated scientists/teachers from NARES in teaching UG/PG courses, other related activities such as student research guidance and developing instructional material/text books including e-learning resources for use in national agricultural education programme and distance education.

The benefit of the Scheme shall be open to all the scientists/teachers at the level of Principal Scientist/ Professor and above from NARES that include State Agriculture Universities, ICAR-Deemed Universities, Central Agriculture Universities, Central Universities having agriculture faculty, Centre and State funded Institutions/Organizations engaged in Agriculture Research, Education, Human Resource Development and Extension. The proposal shall be for teaching of specialized courses and developing instructional material for use in national agricultural education programme including distance education in the field of Agriculture, Horticulture, Veterinary Sciences & Animal Husbandry, Fisheries, Community Science, Dairy Technology and Allied Sciences. **The applicants who are due to retire (having one year or less service) or who are not superannuated before 20th March, 2020 will only be eligible** for consideration under this scheme and may send **8 copies of the application** in the prescribed format (Proforma Part A, B and C).

The guidelines along with the prescribed application format can be downloaded from the ICAR website. You are requested to bring this to the notice of all eligible Scientists/Professors and sponsor one or two cases. The application (hard copy) should reach the undersigned latest by **20th March, 2020 (upto 5.30 PM)** positively. The application received after the last date will not be considered and summarily rejected.
