

Attention is invited to Council's letter No. 19(10)/2004-Estt. IV dated 24.2.2006 wherein amendments in qualifications in all the Functional Groups in Technical Service were notified. For the Functional Groups (i) Field/Farm Technician (ii) Laboratory Technician and (iii) Sub-group Editorial under "Press and Editorial Staff", 'Social Science relevant to Agriculture' is one of the essential qualifications prescribed for recruitment and promotion to the posts in Category-II and III.
