Terms of the Committee: One Year

Terms of Reference:

1. The Anti-Ragging Squad shall ensure compliance of the provisions of UGC Regulations, 2009 and any update from time to time as well as the provisions of any law for the time being in force concerning ragging.
2. The Anti-Ragging Squad shall maintain vigil, oversight and patrolling functions and shall remain mobile, alert and active at all times.
3. The Anti-Ragging Squad shall make surprise raids in Hostels and other places vulnerable to incidence & having the potential of ragging and shall be empowered to inspect such places.
4. The Anti-Ragging Squad will conduct and on-the-spot enquiry into any incident of Ragging referred to it by the Head of the Institute or any member of the faculty or any member of the staff or any student or any parent or guardian or any employee of a service provider or by any other person, as the case may be; and the enquiry report alongwith recommendations shall be submitted to the Anti-Ragging Committee for action under clause (a) of Regulation 9.1.
5. The Anti-Ragging Squad will conduct such enquiry observing a fair and transparent procedure and the principles of national justice and after giving adequate opportunity to the student or students accused of ragging and other witnesses to place before it the facts, documents and views concerning the incident of ragging and considering such other relevant information as may be required.
