5. The supply of Petrol & Diesel may be made on all days in a week for 24 hours.
6. Payment through online mode shall be arranged by Officer-Incharge, Vehicle Pool Section to your authorized representative.
7. The firm has to follow all the terms & conditions as mentioned in the tender document and agreement DEED without any fail.
